- 4) New business – Randy Regehr
 - A. Election of Officers –Tom Stanton as Chairman, Stephanie Springer as Vice Chairwoman, and Lacy Stauffacher as Secretary.
 - B. FY '22 Unexpended Funds – Reno County Community Corrections received \$50,237.67 in unexpended funds from FY '22. This will go towards salaries and housing for clients. A motion to approve the funding delegations was made by Lacy Stauffacher with a second motion by Ray Hemman and all approve.
 - C. Policy Amendments – KDOC completed an audit on policies in the fall. Agency procedures were not changed but written policies needed updated. A motion to approve the changes was made by Brice Burlie with a second motion by Carolyn Parson and all approve.
 - D. Budget and Grant Application Updates – In the near future Randy will submit grant applications for the next fiscal year. This will include a request for an additional \$90,000 for behavioral health allocations above the request from last year.
 - E. DA Tom Stanton discussed House Bill 2026 and the details that still need resolved if accepted. It would begin in January 2024 and offer a diversion for first time drug offenders.

FY'24 Adult Comprehensive Plan Grant

Community Corrections is grant funded primarily with State general funds through the Kansas Department of Corrections. Community Corrections is a statutorily required partnership between the State and County government. The grant provides funding for supervision and behavioral health services for people convicted of a felony offense and assigned to supervision with this agency.

State Statute directs Community Corrections agencies to achieve a success rate of 75% or higher, or improve by 3% from the prior fiscal year. Reno County ended FY'22 with a 67.5% success rate with 141 successful completions and 68 people revoked to prison. For FY'24 the agency set a goal of at least a 71% success rate. The supervisory staff will also be doing quality assurance and coaching of officers to assist them in improving their skills in changing client thinking and behavior. Assessment quality assurance and coaching by Community Solutions Inc. will continue to ensure officers are effectively and accurately completing the risk and needs assessments.
